The Inspectors of Election, LLC (TIE)

2021 Election of Trustees

Polls Close: Thursday, May 6, 2021

The Inspectors of Election, LLC (TIE) was contracted to serve as the oversight authority and independent, third party election service for Willowsford Conservancy 2021 Election of Trustees.

As the duly appointed Inspector of Election of Willowsford Conservancy, we hereby report as follows:

Membership Participation:

1. The total Membership is 2164 and the number of Members in good standing and entitled to vote was 2164.
2. **No** members were duly suspended.
3. TIE determined that a total of **414 (19.13%)** members were represented by online ballot.

Supervision of Election

1. TIE reviewed and supervised the registration process.
2. TIE determined the authenticity, validity, and effect of each of each online ballot received at the offices of TIE prior to the close of the polls.
3. TIE determined all challenges and questions in any way arising in connection with the right to vote.
4. TIE determined if any ballots were invalid and were not counted for any reason.

Election Process

1. There were **two (2)** vacant positions open for election on the Board of Trustees.
2. The two (2) highest vote recipients will be elected to a three-year term.
3. In the event of a tie vote between candidates for the final position, candidates may concede to one another, agree to allow for a flip of the coin to determine the outcome, or if neither of these is agreed to by all parties involved, a Run-Off Election will need to be held.
4. Willowsford Conservancy bylaws do not allow for cumulative voting.
5. The Candidates were as follows, and the votes received by each candidate are listed inline with their name.
